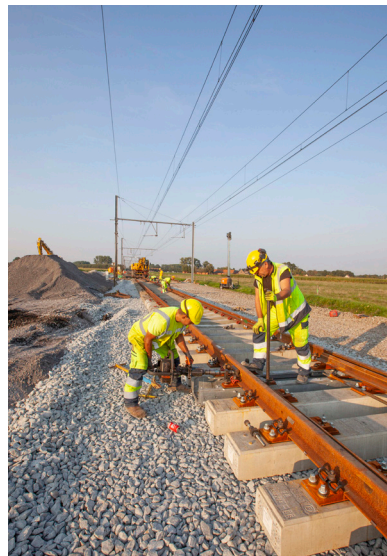


Acquisition of own shares

ACQUISITION OF OWN SHARES

The Board of Directors had decided to launch a share buyback programme within the limits of the (renewed) authorisation to buy back own shares, as granted by the Extraordinary General Meeting of Shareholders of 2 May 2019. This programme is part of the long-term incentive plans for the benefit of the members of the CFE Executive Committee.

CFE launched the buyback programme with the first period starting on 30 June 2022 and ending on 29 July 2022. During this period, 561,000 shares were acquired.

The Board of Directors has decided to restart the share buyback programme for a maximum of 700,000 own shares for the period starting on 31 August 2022 and ending at the latest on 31 December 2022.

This press release includes information on the acquisitions made between 30 November 2022 and 7 December 2022 (included) by KBC Securities as intermediary.

CFE currently owns 359,258 own shares, 1.42% of the outstanding shares.
